Purchases

Alberta Dance has authorized MindBodyOnline to accept payments via Visa or Mastercard for orders submitted through this web-site, and there is no surcharge for using your credit card to make a purchase. In addition to credit card processing, MindBodyOnline also offers ACH(a.k.a. EFT) functionality which allows you to make monthly instalment payments that would come directly out of the account that you dictate. Please be sure to provide the exact contact and email address for order confirmation. Visa and Mastercard purchases made on-line are secured using current encryption technology by MindbodyOnline on behalf of Dance Alberta. All purchases are transacted in Canadian dollars and are subject to Federal Goods and Services Tax (GST).

Cancellation and Refunds Policy;

1. If for any reason a student chooses to withdraw from a class, one month's written notice must be received by the dance school in order to receive credit for the months still remaining for that year. If you are making monthly payments the payments will cease and if payment was pre-paid in full, the refund will be issued from Dance Alberta directly and not through MindBodyOnline even if payment was made through MindBodyOnline initially.
2. No refunds will be issued for withdrawal from classes after April 30th of that dance season unless a Doctor's note is received along with your withdrawal notice.
3. 10% of all costume deposits is non-refundable and after October 30th of the dance season, no part or portion of the costume deposit will be refunded.
4. The Family Membership Fee is non-refundable and non-transferable and expires on August 31st of the next year.
5. Payments returned from the bank for any reason will be subject to an extra NSF charge of \$25.00 per payment.
