

DANCE ALBERTA Privacy Act Form 2010/2011 Season

**GENERAL AUTHORIZATION FOR
COLLECTION AND RETENTION OF INFORMATION**

I hereby confirm that the Student is registered to participate in Dance Alberta's dance education and performance program. I hereby authorize Dance Alberta to collect personal information regarding the Student when information may include the Student's name, address, telephone number, date of birth, measurements for costuming, custodial arrangements, emergency contacts, necessary medical information and years of dance education. Further, I hereby authorize Dance Alberta to collect personal information regarding myself, which may be relevant regarding billing. I understand that all such personal information collected by Dance Alberta will be kept confidential, unless disclosure of such information is specifically authorized by me in writing in this document or at any time hereafter.

I acknowledge that Dance Alberta may print the name and image of the Student in performance programs, Dance Alberta newsletters, advertising posters, brochures, the Dance Alberta website, and press releases, and I specifically authorize the disclosure of the Student's name or image for these purposes.

I further acknowledge that during the instructional year, the Student's class will be viewed by parents of all students registered in the class, and that photographs or video may be taken for purposes of personal viewing by parents at that time. Further, class photographs will be taken, and videos of performances will be made which reveal the image of the Student, and I specifically authorize the disclosure of the Student's image for these purposes.

I understand that Dance Alberta will keep personal information collected regarding the Student or specific billing information regarding me for 5 years after the year in which it is collected and for at least one year after the Student ceases enrollment in the Dance Alberta Programs. Such information will be used to determine appropriate placement for the Student in subsequent dance education programs, exams, competitions, and festivals in which they participate with Dance Alberta. This information will also be used to back up accounts receivable for the purposes of Dance Alberta's annual audit as a not-for-profit organization, and to provide an address for mail-outs and other promotional material.

I hereby accept and voluntarily assume sole responsibility for all my actions and omissions to act in connection with all activities and hereby assume all risk of death, injury, loss or damage to persons or property which arise out of, be caused by or result from all such actions and omissions to act.

I hereby release, remise, completely resolve and forever discharge, and agree to indemnify and save **Dance Alberta**, and regardless of how any such death, injury, loss or damage is caused, which arises out of, is caused by or results from my participation directly or indirectly in the activities even if the cause of such death, injury, loss or damage may have been contributed to in whole or in part by the negligence of **Dance Alberta**, whether volunteer or otherwise, or by the breach or violation of any law, statute, by-law, rule, regulation, or other lawful authority whatsoever.
5. I hereby covenant and agree not to make any demand or claim or bring any suit or action against **Dance Alberta**, caused by or resulting from my participation either directly or indirectly with the activities.
6. I hereby acknowledge and agree that this Waiver and Release of Liability is binding upon myself and my heirs, executors, assigns, and invitees.
